Bond sales is July 26th at 11AM-Closing is August 9th


Gordon's Report:

2. Ultraviolet upgrade project is moving along well. Installed concrete footers for new effluent channel. Working on new effluent manhole. Contractor is waiting on materials that have been delayed from Covid virus.
3. Installed new variable frequency controller at main pump station that was damaged by lightning last October. This project is finally completed. All repairs were covered by insurance minus a \$1000 deductible.
