New Business:

Gordon Eddington February 2025 Report:

- 1. Maintenance on equipment.
- 2. Running belt press composting sludge.
- 3. Working on necessary changes to represent flow measurement as a means of Joint Sewer billing for the Joint Sewer
- 4. Repair of water seal on grit separating system is complete and unit is running fine.
- 5. Discussed location of flow meter on Shortsville sewer line with Kyle (Shortsville) and George (Manchester); both thought it would work out ok. Sewer map of Shortsville indicates that all sewage comes together in the line behind the wash barn. This will be verified when the weather is warmer and manhole covers can be removed.
- 6. February 17, 2025 experienced 7 power outages at eh plan and main pump station due to high winds. There was an issue with one of the pumps at the pump station that is being worked on and will have to wait until warmer weather to possibly pull the pump for maintenance. Board will be updated on this status.
- The main plant generator is approaching its life cycle (40+ years). Gordon will begin looking into project cost estimates to replace the unit.
- Extreme cold weather is difficult on outside plant equipment
- 9. Plant is operating fine.

The next Joint Sewer meeting will take place on April 22, 2025 at 4:30 P.M, at the Shortsville Village Hall. Trustee Henry made a motion, seconded by Trustee Trimm to have adjourn the meeting at 4:50 P.M.
