Mayor Corino opened the Village Board Meeting order at 6:00 P.M.

The Pledge of Allegiance was recited.

The minutes of the previous meeting were prepared beforehand by the Village Clerk-Treasurer and on motion by Trustee Langdon, seconded by Trustee Trimm, voted and carried unanimously to accept as prepared and placed on file. Motion was made by Trustee Langdon, seconded by Trustee Trimm, voted and carried unanimously to accept the November 2025 Trial Balance and Revenue/Expenditure Analysis.

Board Items:

Chief Jason Wagner gave the board Incident Run Log for October and November 2025 and Monthly November 2025 Report. Chief Wagner also gave a copy of OSHA forms for 2022-2024 to Clerk-Treasurer Alexander. Chief Wagner stated that the department will need a policy if they continue to use the body camera with John Perry. Bob Woodhams updated the board on current heating issues at the Fire Hall.

Martha Doody, Shortsville Manchester Area Chamber of Commerce (SMACC), addressed the board regarding their insurance policy that was previously turned in for review. Mrs. Doody stated that the American Canoe Association insurance covers all things in the water and SMACC is hoping to get permission to have the Wild Water Derby. She stated that they can get the Certificate of Liability with the Village listed as additional insured within thirty days of the event, but they don't agree with the limits set.

Other present members in the community stated that it would be unfortunate not to have the event as it benefits many people and businesses in the community.

George Aldrich asked the board if there was anything that can be done to move forward with the approval for the Wild Water Derby.

Trustee Langdon stated that the village can go back to our insurance to see if they recommend lowering any of the current liability limits. Trustee Langdon will follow-up with Mrs. Doody as soon as he receives this information.

WHEREAS, on November 24, 2025 Jack's Kitchen LLC (the "Applicant") notified the Village of Shortsville that it intends to file an On-Premise Liquor License Application with the New York State Liquor Authority for its restaurant located at 17-19 West Main Street, Shortsville, NY 14548; and

WHEREAS, the Applicant has requested the Village waive the statutory thirty (30) day waiting period to allow the Applicant to file an On-Premise Liquor License Application as soon as possible to avoid any delays in obtaining its license to open this summer;

NOW THEREFORE BE IT RESOLVED, that the Village Board of Trustees hereby waives the statutory thirty (30) day waiting period to allow the Applicant to file an On-Premise Liquor License

Application with the New York State Liquor Authority for its restaurant located at 17-19 West Main Street, Shortsville, NY 14548.

Trustee Langdon made a motion, seconded by Mayor Corino, voted and unanimously carried to adopt Resolution 5-2025.
